Good afternoon,

Attached is my affidavit regarding the events of August 24, 2024. I have not been contacted by anyone from Midnite, aside from the good Samaritan who assisted me, to inquire about my well-being or to follow up on the incident. Despite this, I have been informed that those in charge are attempting to use my situation—an already stressful event—to settle a personal vendetta against the individual who helped me. This represents a major failure at the leadership level.

I [REDACTED] affirm the following statements:

1. On the night of August 24, 2024, I departed from 220 W Houston St. with [REDACTED] at approximately 11 p.m. to return to the residence I own in the same neighborhood.
2. Shortly after leaving, I was approached by an individual described as a male, approximately 22-27 years old, and weighing around 150 to 175 lbs. The individual, whom I did not know, appeared extremely intoxicated and requested cigarettes from me. When I informed this individual that I did not have any money, he became aggressive, called me a "white bitch," and demanded money instead. He then brandished a broken glass bottle. I was fearful for my life and safety.
3. [REDACTED] instructed the individual to leave. However, the individual did not comply and continued to act aggressively.
4. During this incident, an individual known to me as [REDACTED], who was present, left the scene. Another person, known to me as [REDACTED] also retreated to safety. [REDACTED] remained with me to protect me until the bar staff came to my aid and directed the aggressor to leave the area.
5. The bartender and several others inside the establishment witnessed the interaction and invited [REDACTED] and me inside. The bartender offered [REDACTED] complimentary drinks for assisting me, but he declined, informing him that he was sober. Instead, he was given a single Coca-Cola - on the house. We stayed for approximately 30 minutes, during which I and several others who witnessed this offered to buy [REDACTED] drinks, which he also declined.
6. I am grateful for [REDACTED]'s assistance that night and was horrified to learn later in the week that it had been suggested he acted inappropriately by individuals who were not present at the scene.
7. I have further received information suggesting that I (and possibly many other people) may be banned from that meeting because of this incident. No one in charge of the meeting has contacted me to hear my account of the events.

I solemnly declare or affirm that the above statements are true to the best of my knowledge and belief and understand that they may be used as evidence in court and are subject to penalty for perjury.
